### Statement of Purpose

To adopt an ordinance that provides for the *licensing and inspection* of all salons in the City of New Haven.

Inspections will focus on *operational standards and maintenance of salons and to minimize health hazards*.

Capability to *respond to and investigate complaints* concerning the operation or condition of a salon.

<u>Provide an accurate count on the number of salons and</u> <u>individuals</u> operating in the City of New Haven which is integral in data collection.

*Effectively enforce* the provisions of CT General Statutes pertaining to such salons.

### Salon Definition

A <u>salon</u> includes any shop, store, day spa or other commercial establishment providing the services of the following:

- *Barber*, as described in section 20-234 of the Connecticut
  General Statutes
- *Hairdresser and/ or cosmetologist*, as defined in section
  20-250 of Connecticut General Statutes
- Nail technician, esthetician, or eyelash technician as defined in section 19a-231 of Connecticut General Statutes
- Massage therapist, as defined in Chapter 384a of the Connecticut General Statutes.

### License to Operate a Salon



No person shall operate or maintain a salon unless said person has obtained a **license to operate** from the Director of Health

Licensure shall occur upon application and/or subsequent inspection and shall be valid for **one (1) year** unless otherwise revoked for cause

### Salon Ordinances in Connecticut

Several cities and health districts that have their own salon ordinances include:

### Plan Review

• *No barbershop, salon, or massage therapy establishment may be relocated, built, remodeled, or converted* without the approval of NHV Health and other relevant city agencies.

 Plans for construction, remodeling, or alteration must be submitted to the Director of Health for approval before work begins. The plans must show the layout, materials, and equipment used. Approval will be granted if the plans meet this regulation and state laws.

• *Before opening, the Director of Health or their agent will inspect the establishment* to ensure it complies with approved plans, this regulation, and state laws.

#### Inspection Frequency

#### Salons will be inspected *annually*

or

<u>As deemed necessary</u> as a result of a failed inspection, complaint, or a public health emergency

#### Fees

Salons will be required to obtain an *annual license* from NHV Health *to operate*.

The fees are as follows:

- A \$150.00 annual license fee + a \$250.00 annual inspection fee (Total= \$400.00)
- A \$100.00 application fee for all new licenses/ establishments will be required
- A fee of \$150.00 will be charged if a second reinspection is required

Fees are subject to change based on the approved annual budget by the City of New Haven's Board of Alders, which is included in the annual city budget and may be amended.



Approved Method Use

# Plumbing

#### Must:

- Have approved fixtures
- Be kept clean
- Be maintained
- Have no cross connections, back

siphonage or backflow present

Toilet and Hand Washing Facilities

#### Must:

- Have an adequate number
- Be conveniently located <u>and</u> accessible
- Have clean fixtures in good repair
- Have liquid soap and single use towels

present

### Garbage Disposal

#### Interior must:

- Have an adequate number of containers provided
- Be covered

#### Exterior must:

- Have dumpsters properly located
- Keep dumpster area clean

Floors, Walls, and Ceilings Floors, Walls, and Ceilings must:

- Be properly constructed
- Be kept clean

Attached equipment and fixtures must:

- Be properly constructed and maintained
- Be kept clean

#### Ventilation

Must:

• Be adequate

• Have no excess heat or odors

### Storage

Cabinets for storing clean linens must:

- Be clean
- Have tight-fitting doors

Dirty linens must:

• Be placed in a covered receptacle (laundry basket)

#### Housekeeping

- Salon must be separate from living and sleeping quarters
- No food or drink sales onsite unless permitted by NHV Health
- No animals or pets allowed in the work space

• Workspace must be properly maintained

• First aid kit readily available and stocked

### Personnel

- All personnel have proper licensure from CT
  DPH
- All licenses posted in a conspicuous place
- No personnel with infectious or communicable diseases present
- Good hygienic practices followed (including no smoking)
- Clean outer clothing
- Hands properly washed before serving each customer

Utensils and Equipment Handling (Other Than Single Service)

#### No Communal:

- Neck dusters
- Power puffs
- Make-up brushes or sponges
- Shaving brushes
- Shaving mugs
- Credo blades

Hair clippings cleaned up often from floor and equipment

Sanitary paper strip placed around the individual's neck before putting on a cape

Headrests covered with paper or a towel in between customers

Utensils and Equipment Handling (Other Than Single Service) Shaker top container used for lotions or powders

Alum or other material to stop the flow of blood provided in powder or liquid form

Adhesive glue approved by the FDA

Device to hold eyebrow thread

All equipment and utensils used on customers are clean and sanitized in between uses

Follow proper disinfection techniques (including using proper solutions)

## Equipment

Shampoo sink provided (if applicable)

At least one hand sink provided for employee use

Utility sink provided to clean instruments

Disinfected utensils kept in a sanitary manner between uses

If linens are washed onsite, proper sanitizing procedure is followed

Adequate sanitizing procedures followed for pedicure tubs

Proper use of single-serve items

### Correction of Violations

If any establishment is found to be unsanitary, the Director of Health shall issue a written order requiring it to correct any inspection violations identified within a specific time frame.

If the establishment fails to make said correction within this period, the establishment's license may be revoked or suspended.

### Benefits

#### Prevents *infection and disease*.

Protects both employees and customers.

#### Guarantees *all salons are licensed*.

Promotes *standardized* public health practices and guidelines by ensuring the sanitary conditions of salons.

#### Guarantees that *all employees are licensed to practice.*

- Per CT State Law, all individuals must hold a license to perform a service and must have a current/active license available for review during inspection.
- Provides contact information with salons for Public Health PSA / Education
- Provides an accurate database of licensees and an accurate number of salons operating in the City of New Haven.
